- I understand and agree that Materials will be deemed irrevocably and perpetually licensed to LKR by this agreement. In addition, I waive (to the fullest extent possible) the right to inspect or approve the use of any finished product that includes the Materials, including, but not limited to, written or electronic copy.
- I hereby irrevocably authorize LKR to edit, alter, adapt, copy, exhibit, publish or distribute any Materials for purposes of providing educational resources to teachers, students and families, furthering LKR’s mission, publicizing LKR’s programs or LKR itself, for any other lawful purpose. Consequently, I forever waive (to the fullest extent possible) so-called “droit morale” or “moral rights” of authors.
- I hereby indemnify, hold harmless, release, and forever discharge LKR and its officers, directors, employees, agents, affiliates, licensees, and partners, and their respective officers, directors, and employees, from all claims, demands, and causes of action which I, my heirs, representatives, executors, administrators, or any other persons acting on my behalf or on behalf of my estate have or may have by reason of this authorization or LKR’s use of the Materials.
