- I hereby irrevocably authorize Music Will to edit, alter, adapt, copy, exhibit, publish or distribute any Materials for purposes of providing educational resources to teachers, students and families, furthering Music Will’s mission, publicizing Music Will’s programs or Music Will itself, for any other lawful purpose. Consequently, I (and minor child, if applicable) forever waive (to the fullest extent possible) so-called “droit morale” or “moral rights” of authors.
